











# CONCLUSION

- Increase in skin hydration rather significantly.
- Dermal density increased with more in older subjects possible increase in collagen
- Sebum normalization tendency particularly in lower sebum cases.

## FINAL CONCLUSION

The obtained results show that the test product:

- 1. Has a very good moisturizing effect.
- 2. Seboregulating effect-Oily, normal & dry skin.
- 3. Skin firmness dramatically improved on the face and neck.





### 4. Reduction of crow's feet wrinkles.

- 5. Reduction in skin roughness, measured that lead to an improvement of skin visual appearance.
- 6. Dermal density increased good firming effect.





- 7. 86% volunteers rated the product as good / very good
- 8. Majority of the participants (83%) noticed a visible improvement on their face, including an increase in facial radiance.
- 9. Safe & non irritating

In brief, besides good tolerance level, radiance, smoothness, firmness. Efficacy were attested by the great majority of the volunteers.
